Route A: January 2025-December 2032

Route B: January 2026-December 2028

Route B is for candidates who began their post-graduate studies on the ABAI 5th VCS before 1 September 2023 using the [BACB Pathway 2: Behaviour Analytic Coursework](#) standards.

Prior to 1 January 2026 the candidates should apply directly to the BACB. After 2026, candidates will submit the BACB paperwork directly to the UK-SBA.

Route D: January 2026-December 2027

Route D is for candidates who have a doctorate degree in an area related to behaviour analysis. Candidates must have completed a doctoral dissertation on a topic that includes behaviour analysis, and must have been practising in a role that includes behaviour analysis for at least 10 years. Please contact the UK-SBA to discuss individual applications. This pathway is open between 2026-2027.

Practical experience working in a role which includes behaviour analysis for at least 10 years. Professionals might work in fields such as Positive Behaviour Support, Acceptance and Commitment Therapy, and Organisational and Behaviour Management.	<ul style="list-style-type: none">• A professional CV that details the work in behaviour analysis• A letter of reference from a full UKBA(cert)
Successful candidates will be awarded probationary status as UKBA(cert) for one year. Route E: January 2026-December 2032

Route E is for candidates who hold the BCBA/BCBA-D certification.

After 2026, candidates who possess the BCBA/BCBA-D certification are invited to apply to become certified as probationary UKBA(cert).
